1. This Act, which amends the Prevention of Crimes Act, may be cited as the Prevention of Crimes (Amendment) Act 1998.

2. The sections of the Principal Act mentioned in the first column of the Schedule are hereby amended in the manner specified in the corresponding entry in the second column of the Schedule.

### SCHEDULE S.2

FIRST COLUMN SECTIONS	SECOND COLUMN AMENDMENTS
Section 7	For "seven thousand five hundred dollars" substitute "fifteen thousand dollars", for "fifteen thousand dollars", substitute "thirty thousand dollars", for "one month" substitute "two months" and for "three months", substitute "six months".
Section 8	In paragraph (b), for "fifteen thousand dollars" substitute "thirty thousand dollars".
Section 9	In subsection (2), for "seven thousand five hundred dollars" substitute "not less than seven thousand five hundred dollars nor more than fifteen thousand dollars" and for "ten thousand dollars" substitute "not less than ten thousand dollars nor more than twenty thousand dollars".
Section 12 (a)	In subsection (1) (a), for "twenty thousand dollars" substitute "not less than twenty thousand dollars nor more than forty thousand dollars" and for "six months" substitute "twelve months."

Section i8 For "thirty thousand dollars' substitute "not less than thirty thousand dollars nor more than sixty thousand dollars" and for "four months" substi-

tute eight months".
