AN ACT to amend the Mining Act.

A.D. 1984 Enacted by the Parliament of Guyana:—

Short title. 1. This Act, which amends the Mining Act, may be cited
Cap. 65:01 as the Mining (Amendment) Act 1984.

Amendment of section 10 of the Principal Act. 2. Section 10(4) of the Principal Act is hereby amended by the substitution, for the words "to a fine of one thousand five hundred dollars or to imprisonment for six months", of the words "to a fine of twenty-five thousand dollars together with imprisonment for five years".

Amendment of section 40 of the Principal Act. 3. Section 40(2) of the Principal Act is hereby amended by the substitution, for the words "to a fine of three hundred dollars, and to a further fine of thirty dollars", of the words "to a fine of ten thousand dollars together with imprisonment for two years, and to a further fine of one thousand dollars".

Amendment of section 63 of the Principal Act. 4. Section 63 of the Principal Act is hereby amended by the substitution, for the words beginning with "one thousand five hundred" and ending with "six months", of the words "twenty-five thousand dollars together with imprisonment for five years".

Amendment of section 79 of the Principal Act. 5. Section 79 of the Principal Act is hereby amended by the repeal of subsection (2) and the substitution therefor of the following subsection —

"(2) The Minister may prescribe a fine not exceeding twenty-five thousand dollars or imprisonment not exceeding five years or both as penalty for the breach of any regulation."

Amendment of section 80 of the Principal Act. 6. Section 80 of the Principal Act is hereby amended, by the substitution, for the words "to a fine of three hundred dollars", of the words "to a fine of twenty-five thousand dollars together with imprisonment for five years".
