AN ACT to amend the Rent Restriction Act and the Rice Farmers (Security of Tenure) Act and to make certain incidental provision on the expiry of the Rent Control (Special Provisions) Act.

short title and commencement.

- 1. This Act may be cited, the Rent Control Enactments (Amendment) Act 1981 and schall be deemed to have come into operation on 1st January 31.
- Amendment 2. The Rent Restriction Act is hereby amended in the of Rent Restriction Act, following respects Cap. 36:23.
 - (a) by substituting in section 9(1) for the words "section 15(1) (a) and (b)" the words "section 15 (1) (a) and (b) and (1A)";
 - (b) by inserting in section 15, after subsection (1) the following subsection as subsection (1A) --
 - "(1A) Notwithstanding anything contained in subsection (1), in computing under that subsection the amount by which the increased rent of premises, to which the Rent Control (Special Provisions) Act applied and which were the subject matter of a tenancy at 31st December, 1980, may exceed the standard rent in respect of any period after that date
 - (a) no account shall be taken of expenditure incurred by the landlord on the improvement or structural alteration of the premises during the period when that Act was in force; and
 - (b) increase, made in respect of the period when that Act was in force, in the amount payable by the landlord on account of rates and taxes over the corresponding amount paid or payable in respect of the yearly period which included the 31st December, 1973 shall be excluded."
- The Rice Farmers (Security of Tenure) Act is hereby amended by substituting in section 23(1) a colon for the full stop (Security of at the end of paragraph (d) and by inserting the following proviso (Tenure) Act, itamediately thereafter —

"Provided that in computing the amounts which may be added to the basic rent under this subsection in respect of a holding to which the Rent Control (Special Provisions) Act applied and which was the subject matter of a tenancy at 31st December. 1980, in respect of any period after that Act was in force, in the amounts referred to in paragraphs (a) to (d)(inclusive), over the corresponding arounts paid or payable in respect of the yearly period inch included the 31st December, 1973, shall be excluded."

4. The provisions contained in section 54 of the Interpre-Effect of tation and General Clauses Act shall apply mutatis mutandis to expiry of the expiry of the Rent Control (Special Provisions) Act in the (Special same manner as they would apply when a written law is repealed Provisions) Act.
